Introduction & objectives

The FIFA Football Agent exam is not merely an administrative formality; it is a rigorous test of technical competence designed to filter access to an increasingly professionalised industry.

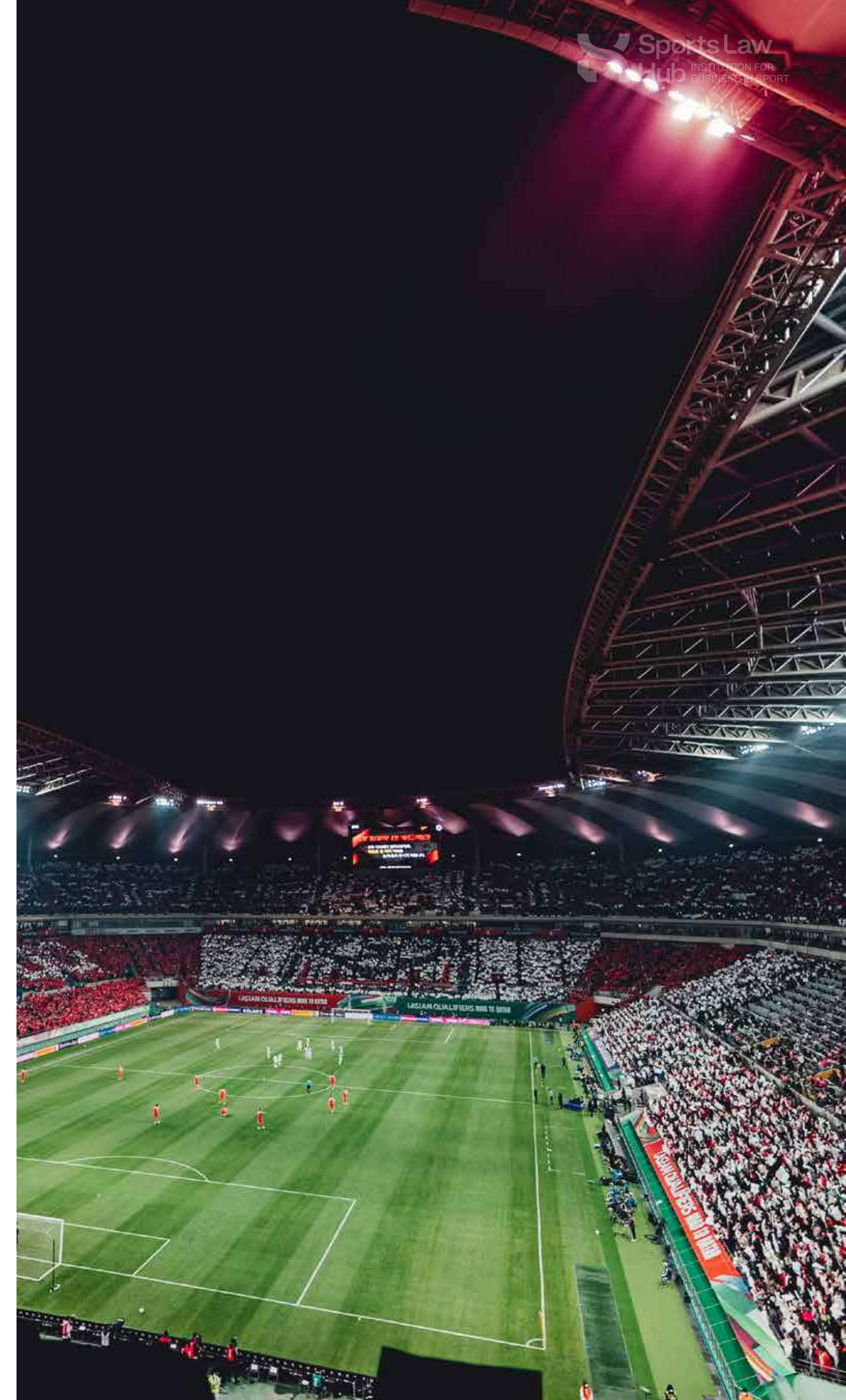
